

Advance Beneficiary Notice of Noncoverage (ABN)

NOTE: If Medicare (and most health insurance) doesn't pay for items below, you may have to pay. Medicare (and most other insurances) does not pay for everything, even some care that you or your health care provider have good reason to think you need. We expect Medicare may not pay for the items below.

WHAT YOU NEED TO DO NOW:

- Read this notice, so you can make an informed decision about your care.
- Ask us any questions that you may have after you finish reading.
- Choose an option below about whether to receive the item(s) listed above.

Note: If you choose Option 1 or 2, we may help you to use any other insurance that you might have, but Medicare cannot require us to do this.

OPTIONS: Check only one box. We cannot choose a box for you.

OPTION 1. I want the item(s) _____ listed above. You may ask to be paid now, but I also want Medicare (or my insurance) billed for an official decision on payment, which is sent to me on a Medicare Summary Notice (or EOB from my insurance). I understand that if Medicare (or my insurance) doesn't pay, I am responsible for payment, but I can appeal to Medicare (or my insurance) by following the directions on the MSN. If Medicare (or my insurance) does pay, you will refund any payments I made to you, less co-pays or deductibles.

OPTION 2. I want the item(s) _____ listed above, but do not bill Medicare (or my insurance). You may ask to be paid now as I am responsible for payment. I cannot appeal if Medicare is not billed.

OPTION 3. I don't want the item(s) _____ listed above. I understand with this choice I am not responsible for payment, and I cannot appeal to see if Medicare (or my insurance) would pay.
